An Act to Allow the Town of Chester to Annex a Certain Parcel of Land. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 205.)

Presented by Senator MICHAUD of Penobscot; Cosponsored by Representative: STANLEY of Medway. Referred to Joint Standing Committee on State and Local Government. Public Hearing 05/05/97. Majority (OTP-AM) Accepted 05/23/97.
