Presented by Senator TREAT of Kennebec; Cosponsored by Senator NUTTING of Androscoggin, Representatives: BUMPS of China, JONES of Greenville, KERR of Old Orchard Beach. Referred to Joint Standing Committee on Labor. Public Hearing 02/04/98. OTP-AM Accepted 02/25/98. Amended by: CA S-460. Final Disposition: Emergency Finally Passed, Signed 03/12/98, RESOLVE LAWS, Chapter 90.
