Resolve, to Reimburse Cable Companies for Expenditures Made while Participating in the Business Equipment Tax Reimbursement Tax Program. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 203.) Presented by Representative O'NEAL of Limestone; Cosponsored by Representatives: BAGLEY of Machias, BUNKER of Kossuth Township, GAGNON of Waterville, KNEELAND of Easton, SIROIS of Caribou, WHEELER of Bridgewater, Senator KIEFFER of Aroostook. Referred to Joint Standing Committee on Taxation. Public Hearing 02/18/98. Minority (OTP-AM) Accepted 04/01/98. Amended by: CA H-1043.
