LD 2076 / HP1477

Original Title: An Act to Require All Regulated Public Utilities to Report to the Public Utilities Commission the Sale, Lease or Other Transfer of Assets Paid for by Ratepayers.
New Title: An Act to Require Certain Utilities to Report Transfers of Assets. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 203.)
Presented by Representative O'NEAL of Limestone; Cosponsored by Senator CAREY of Kennebec and Representatives: BAGLEY of Machias, BUNKER of Kossuth Township, COWGER of Hallowell, GIERINGER of Portland, LaVERDIERE of Wilton, RINES of Wiscasset, WHEELER of Bridgewater, Senator KILKELLY of Lincoln. Referred to Joint Standing Committee on Utilities and Energy. Public Hearing 02/18/98. House: Insist on Engrossment 03/27/98; Senate: Adhere to Minority (ONTP) 04/01/98. Final Disposition: Died Between Houses 04/01/98.
