An Act to Amend the Laws Regarding the Consensus Revenue Forecasting Process. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 203.) Presented by Senator LAWRENCE of York; Cosponsored by Senators: CLEVELAND of Androscoggin, MICHAUD of Penobscot, PINGREE of Knox, Representatives: KONTOS of Windham, MITCHELL of Vassalboro. Referred to Joint Standing Committee on Appropriations and Financial Affairs. Public Hearing 02/10/98. Majority (OTP-AM) Accepted 03/23/98. Amended by: CA S-554. Final Disposition: Enacted, Signed 04/01/98, PUBLIC LAWS, Chapter 655.
