An Act to Clarify the Responsibilities of the Advisory Commission on Radioactive Waste during the Decommissioning of Maine Yankee. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 203.) Presented by Senator TREAT of Kennebec; Cosponsored by Senators: CAREY of Kennebec, KILKELLY of Lincoln, LAWRENCE of York, NUTTING of Androscoggin, Representatives: COWGER of Hallowell, ROWE of Portland, SHIAH of Bowdoinham. Referred to Joint Standing Committee on Natural Resources. Public Hearing 02/13/98. Majority (OTP-AM) Accepted 03/24/98. Amended by: CA S-514, SA/CA S-540. Final Disposition: Emergency Enacted, Signed 04/03/98, PUBLIC LAWS, Chapter 700.
