An Act to Repeal Certain Changes Made to State Employee and Teacher Retirement Benefits. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 203.) Presented by Representative BERRY of Belmont; Cosponsored by Representatives: HATCH of Skowhegan, DUNLAP of Old Town, JOY of Crystal, MURPHY of Kennebunk, SKOGLUND of St. George, USHER of Westbrook, VEDRAL of Buxton, Senators: CATHCART of Penobscot, DAGGETT of Kennebec. Referred to Joint Standing Committee on Labor. Public Hearing 02/10/98. Majority (OTP-AM) Accepted 03/27/98. Amended by: CA H-1054. Final Disposition: Died on Adjournment 04/09/98.
