An Act to Amend the Laws Concerning Participating Local Districts in the Maine State Retirement System. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 203.) Presented by Representative HATCH of Skowhegan; Cosponsored by Representatives: AHEARNE of Madawaska, PENDLETON of Scarborough, RINES of Wiscasset, ROWE of Portland, SAXL of Portland, STANLEY of Medway, Senator TREAT of Kennebec. Referred to Joint Standing Committee on Labor. Public Hearing 02/17/98. Majority (OTP-AM) Accepted 03/25/98. Amended by: CA H-1009. Final Disposition: Enacted, Signed 04/03/98, PUBLIC LAWS, Chapter 709.
