An Act to Promote the Expansion of Pari-mutuel Simulcast Wagering. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 203.) Presented by Representative VIGUE of Winslow; Cosponsored by Senator CAREY of Kennebec and Representatives: CLARK of Millinocket, POULIN of Oakland, TRUE of Fryeburg, TUTTLE of Sanford. Referred to Joint Standing Committee on Legal and Veterans Affairs. Public Hearing 02/19/98. Final Disposition: Ought Not to Pass Pursuant to Joint Rule 310 03/02/98.
