An Act to Reduce Income and Property Taxes. (GOVERNOR'S BILL). Presented by Representative TRIPP of Topsham; Cosponsored by Senator RUHLIN of Penobscot and Representatives: CAMERON of Rumford, McELROY of Unity. Referred to Joint Standing Committee on Taxation. Public Hearing 02/24/98. Majority (OTP-AM) Accepted 03/20/98. Amended by: CA H-876. House: Enacted 03/24/98; Senate: Tabled Unassigned 4/2/98. Final Disposition: Died on Adjournment 04/09/98.
