LD 2224 / SP0826

Original Title: An Act to Authorize a General Fund Bond Issue in the Amount of \$16,000,000 to Construct Water Pollution Control Facilities; to Close and Clean Up Municipal Solid Waste Landfills; to Clean Up Tire Stockpiles; to Investigate, Abate, Clean Up and Mitigate Hazardous Substance Discharges; to Mitigate Storm Water Pollution through a Comprehensive Watershed Protection Program; and to Make Drinking Water System Improvements. New Title: An Act to Authorize a General Fund Bond Issue in the Amount of \$7,000,000 to Construct Water Pollution Control Facilities; to Clean Up Tire Stockpiles; to Investigate, Abate, Clean Up and Mitigate Hazardous Substance Discharges; and to Make Drinking Water System Improvements. (GOVERNOR'S BILL). Presented by Senator MICHAUD of Penobscot; Cosponsored by Senator PARADIS of Aroostook, Representatives: COWGER of Hallowell, KNEELAND of Easton. Referred to Joint Standing Committee on Appropriations and Financial Affairs. Public Hearing 03/09/98. Majority (OTP-AM) Accepted 04/02/98. Amended by: CCA (Changed Title) H-1169. Enacted, Signed 04/16/98, P & S LAWS, Chapter 92. Final Disposition: Approved in Referendum 11/03/98 (In favor: 289,771; Opposed: 111,450).
