An Act to Create the Kennebec Regional Development Authority. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 205.) Presented by Representative MITCHELL of Vassalboro; Cosponsored by Senator MILLS of Somerset and Representatives: MADORE of Augusta, POULIN of Oakland, VIGUE of Winslow, Senator CAREY of Kennebec. Referred to Joint Standing Committee on Business and Economic Development. Public Hearing 03/09/98. Majority (OTP) Accepted 03/20/98. Final Disposition: Emergency Enacted, Signed 04/03/98, P & S LAWS, Chapter 79.
