An Act to Amend the Law Concerning Tax Base Sharing. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 205.) Presented by Representative MITCHELL of Vassalboro; Cosponsored by Senator DAGGETT of Kennebec and Representatives: GAGNON of Waterville, GREEN of Monmouth, MADORE of Augusta, TESSIER of Fairfield, TRIPP of Topsham, VIGUE of Winslow, Senator RUHLIN of Penobscot.
