An Act to Authorize a General Fund Bond Issue in the Amount of \$10,000,000 to Finance the Acquisition of Land for Conservation, Outdoor Recreation and Wildlife Habitat Protection and Farmland Preservation and to Access \$5,000,000 in Matching Contributions From Public and Private Sources. (GOVERNOR'S BILL). Presented by Senator PINGREE of Knox; Cosponsored by Representative MITCHELL of Vassalboro and Senators: BENOIT of Franklin, HARRIMAN of Cumberland, KILKELLY of Lincoln, Representatives: CIANCHETTE of South Portland, OTT of York, SAXL of Portland, SPEAR of Nobleboro.
