Resolve, Authorizing the Transfer of the Old Hancock County Jail on State Street, Ellsworth from Hancock County to the Ellsworth Historical Society. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 205.) Presented by Representative POVICH of Ellsworth; Cosponsored by Senator GOLDTHWAIT of Hancock and Representatives: BIGL of Bucksport, BUNKER of Kossuth Township, JONES of Bar Harbor, LAYTON of Cherryfield, PERKINS of Penobscot, PINKHAM of Lamoine, VOLENIK of Brooklin, Senator RUHLIN of Penobscot.
