Resolution, Proposing an Amendment to the Constitution of Maine to Amend the Timing of Elections Following the Submission of a Petition for People's Veto. Presented by Senator CLEVELAND of Androscoggin; Cosponsored by Senators: ABROMSON of Cumberland, GOLDTHWAIT of Hancock, NUTTING of Androscoggin, Representatives: BUMPS of China, CAMERON of Rumford, ETNIER of Harpswell, SHIAH of Bowdoinham, TAYLOR of Cumberland. Referred to Joint Standing Committee on State and Local Government. Public Hearing 03/16/98. Majority (OTP-AM) Accepted 04/01/98. Amended by: CA S-607. House: Adhere to Failed Final Passage 04/02/98; Senate: Finally Passed 04/02/98. Final Disposition: Died Between Houses 04/02/98.
