Presented by Representative GLYNN of South Portland; Cosponsored by Senator AMERO of Cumberland and Representatives: BELANGER of Caribou, WATERHOUSE of Bridgton, CAMPBELL of Holden, JACOBS of Turner, LABRECQUE of Gorham, MacDOUGALL of North Berwick, MACK of Standish, McDONOUGH of Portland, McNEIL of Rockland, SHOREY of Calais, Senator DAVIS of Piscataquis. Referred to Joint Standing Committee on Taxation. Public Hearing 03/01/99. House: Insist on Engrossment 04/26/99, Conference Committee 04/26/99.
