An Act to Amend the Maine Workers' Compensation Act of 1992 as it Relates to Compensation for Amputation of a Body Part. Presented by Representative GOODWIN of Pembroke; Cosponsored by Representatives: BOLDUC of Auburn, BROOKS of Winterport, CHIZMAR of Lisbon, CLARK of Millinocket, HATCH of Skowhegan, STANLEY of Medway. Referred to Joint Standing Committee on Labor. Public Hearing 03/18/99. Majority (OTP) Accepted 06/04/99. Amended by: SA S-380. Enacted 06/05/99. Vetoed by Governor 06/17/99. Final Disposition: Veto Sustained 06/18/99.
