RESOLUTION, Proposing an Amendment to the Constitution of Maine to Require a Referendum for a People's Veto to Be Held at a Primary or General Election. Presented by Representative WILLIAMS of Orono; Cosponsored by Senator ABROMSON of Cumberland and Representatives: CHIZMAR of Lisbon, DUNLAP of Old Town, McGLOCKLIN of Embden, TOWNSEND of Portland, Senator CATHCART of Penobscot. Referred to Joint Standing Committee on State and Local Government. Public Hearing 02/10/99. Final Disposition: Indefinitely Postponed 04/14/99.
