Referred to Joint Standing Committee on Legal and Veterans Affairs. Public Hearing 01/26/99. House: Engrossment 03/25/99, Insist on Engrossment 04/14/99, Conference Committee 04/14/99. Senate: Minority (ONTP) Accepted 04/13/99, Adhere to Minority (ONTP) 04/15/99. Final Disposition: Died Between Houses 04/26/99.
