An Act to Impose Stricter OUI Penalties on Operators of Watercraft, ATVs and Snowmobiles. Presented by Representative CAMERON of Rumford; Cosponsored by Representatives: AHEARNE of Madawaska, CLARK of Millinocket, CROSS of Dover-Foxcroft, DAVIS of Falmouth, DUNLAP of Old Town, JOY of Crystal, POVICH of Ellsworth. Referred to Joint Standing Committee on Inland Fisheries and Wildlife. Public Hearing 02/09/99. Majority (OTP-AM) Accepted 05/14/99. Amended by: CA H-509.
