An Act to Restrict Circulators of Initiated Petitions from Being within 250 Feet of Voting Places. Presented by Senator KIEFFER of Aroostook; Cosponsored by Senators: BENOIT of Franklin, CASSIDY of Washington, MacKINNON of York, Representatives: DUNLAP of Old Town, KNEELAND of Easton, MAYO of Bath, SHERMAN of Hodgdon. Referred to Joint Standing Committee on Legal and Veterans Affairs. Public Hearing 02/23/99. Final Disposition: Indefinitely Postponed 05/05/99.
