An Act to Exempt Military Retirees from State Income Taxes. Presented by Representative POVICH of Ellsworth; Cosponsored by Senator MURRAY of Penobscot and Representatives: BRAGDON of Bangor, DAVIDSON of Brunswick, JONES of Pittsfield, LOVETT of Scarborough, CAMERON of Rumford, Senator HARRIMAN of Cumberland. Referred to Joint Standing Committee on Taxation. Public Hearing 03/01 /99. House: Majority (OTP-AM) Accepted 05/06/99, Adhere to Engrossment 06/02/99. Senate: Indefinitely Postponed 06/01/99, Adhere to Indefinite Postponement 06/05/99. Final Disposition: Died Between Houses 06/05/99.
