An Act to Increase the Length of Probation for a Person Convicted of Domestic Violence. Presented by Representative STANLEY of Medway; Cosponsored by Representatives: BOLDUC of Auburn, BRYANT of Dixfield, CLARK of Millinocket, CROSS of Dover-Foxcroft, JOY of Crystal, O'NEAL of Limestone, Senator DAVIS of Piscataquis. Referred to Joint Standing Committee on Criminal Justice. Public Hearing 02/09/99. Majority (OTP-AM) Accepted 05/10/99. Amended by: CA H-451, SA/CA S-427. Final Disposition: Enacted, Signed 06/11/99, PUBLIC LAWS, Chapter 492.
