LD 797 / SP0279

An Act to Authorize a General Fund Bond Issue in the Amount of \$9,400,000 to Enable Maine Public Broadcasting to Implement the Federally Mandated Conversion to Digital Broadcasting. Presented by Senator AMERO of Cumberland; Cosponsored by Representative SAXL of Portland and Senators: ABROMSON of Cumberland, LAWRENCE of York, PINGREE of Knox, SMALL of Sagadahoc, Representatives: MURPHY of Kennebunk, ROWE of Portland, STEVENS of Orono. Referred to Joint Standing Committee on Appropriations and Financial Affairs. Public Hearing 04/06/99. OTP-AM Accepted 06/05/99. Amended by: CA S-443. Enacted, Signed 06/17/99, P & S LAWS, Chapter 57. Final Disposition: Approved in Referendum 11/02/99 (In favor: 264,653; Opposed: 146,696).
