Resolve, to Study Outdated, Contradictory and Unenforced Laws. Presented by Representative CAMPBELL of Holden; Cosponsored by Senator CAREY of Kennebec and Representatives: BROOKS of Winterport, KNEELAND of Easton, PERKINS of Penobscot, Senators: CASSIDY of Washington, FERGUSON of Oxford, MILLS of Somerset. Referred to Joint Standing Committee on State and Local Government. Public Hearing 03/17/99. House: Insist on Engrossment 03/21/00, Conference Committee 03/21/00; Senate: Majority (ONTP) Accepted 03/16/00, Adhere to Majority (ONTP) 03/21/00. Final Disposition: Died Between Houses 03/21/00.
