An Act to Prohibit the Employment of Professional Strikebreakers. Presented by Representative SAMSON of Jay; Cosponsored by Senator DOUGLASS of Androscoggin and Representatives: BERRY of Livermore, BRYANT of Dixfield, CLARK of Millinocket, DAVIS of Falmouth, HATCH of Skowhegan, JABAR of Waterville, TRACY of Rome, VOLENIK of Brooklin. Referred to Joint Standing Committee on Labor. Public Hearing 03/11/99. Majority (OTP-AM) Accepted 05/17/99. Amended by: CA H-484. Enacted 05/20/99. Vetoed by Governor 06/01/99. Final Disposition: Veto Sustained 06/01/99.
