RESOLUTION, Proposing an Amendment to the Constitution of Maine to Promote Historic and Scenic Preservation. Presented by Senator AMERO of Cumberland; Cosponsored by Senator ABROMSON of Cumberland, Representative BRENNAN of Portland. Referred to Joint Standing Committee on Taxation. Public Hearing 03/18/99. OTP-AM Accepted 04/26/99. Amended by: CA S-96. Finally Passed, CON RES LAWS, Chapter 2. Final Disposition: Approved in Referendum 11/02/99 (In favor: 221,997; Opposed: 185,121).
