An Act to Provide Equal Treatment in the Taxation of Public Pensions. Presented by Senator DAGGETT of Kennebec; Cosponsored by Representative GAGNON of Waterville and Senators: HARRIMAN of Cumberland, KONTOS of Cumberland, Representatives: BERRY of Belmont, LEMONT of Kittery, MITCHELL of Vassalboro, TESSIER of Fairfield, TUTTLE of Sanford. Referred to Joint Standing Committee on Taxation. Public Hearing 03/08/99. Majority (OTP-AM) Accepted 05/28/99. Amended by: CA S-348. Enacted 06/04/99. Vetoed by Governor 06/11/99. Final Disposition: Veto Sustained 06/18/99.
