RESOLUTION, Proposing an Amendment to the Constitution of Maine to Revoke Voting Rights of Convicted Felons While they are in Prison. Presented by Senator BENNETT of Oxford; Cosponsored by Senators: DAVIS of Piscataquis, MITCHELL of Penobscot, PENDLETON of Cumberland, Representatives: BUMPS of China, LABRECQUE of Gorham. Referred to Joint Standing Committee on Legal and Veterans Affairs. Public Hearing 04/06/99. House: Indefinitely Postponed 05/12/99, Adhere to Indefinite Postponement 05/24/99. Senate: Insist on Engrossment 05/20/99, Conference Committee 05/20/99. Final Disposition: Died Between Houses 05/24/99.
