Referred to Joint Standing Committee on Business and Economic Development. Public Hearing 04/06/99. Report A (OTP-AM) Accepted 05/07/99. Amended by: CA S-190, SA/CA S-408. Enacted 06/04/99. Vetoed by Governor 06/16/99. Final Disposition: Veto Sustained 06/18/99.
