LD 1883 / SP0661 (ND 2643 / SP1053)

An Act to Ensure that Certain Land Transfers Accomplished through Stock Transfers are not Exempt from the Transfer Tax. Presented by Senator MICHAUD of Penobscot; Cosponsored by Senators: NUTTING of Androscoggin, TREAT of Kennebec, Representatives: SHIAH of Bowdoinham, STANLEY of Medway. Referred to Joint Standing Committee on Taxation. Public Hearing 04/05/99. OTP-ND (New Title) Accepted 03/22/00. New Draft New Title: An Act Ensuring that Certain Land Transfers Accomplished through Stock Transfers are not Exempt from the Transfer Tax. LD 2643 / SP1053. Referred to Joint Standing Committee on Taxation. Public Hearing 03/27/00. In Senate, committee report presented, but Chair ruled New Draft not properly before body and returned it to committee. Committee returned report on Original Draft. House: Majority (ONTP) Accepted 04/13/00. Senate: Minority (OTP-AM) Accepted and Engrossed as Amended 04/13/00. House and Senate: Conference Committee Report Accepted - Unable to Agree 04/25/00. Final Disposition: Died in Concurrence 04/25/00.
