An Act to Appropriate Funds for Marketing to Promote Economic Development. Presented by Senator MICHAUD of Penobscot; Cosponsored by Representative CLARK of Millinocket and Senators: KONTOS of Cumberland, LONGLEY of Waldo, Representative STANLEY of Medway. Referred to Joint Standing Committee on Appropriations and Financial Affairs. Public Hearing 04/08/99. Majority (OTP-AM) Accepted 05/03/99. Amended by: CA S-120, SA/CA S-409. Enacted 06/04/99, Vetoed by Governor 06/16/99. Final Disposition: Veto Sustained 06/18/99.
