An Act to Prohibit the Scalping of Entertainment Tickets. Presented by Representative SULLIVAN of Biddeford; Cosponsored by Representatives: BAGLEY of Machias, DUDLEY of Portland, GERRY of Auburn, NORBERT of Portland, O'NEIL of Saco, SANBORN of Alton, TWOMEY of Biddeford, Senator RAND of Cumberland. Referred to Joint Standing Committee on Legal and Veterans Affairs. Public Hearing 01/04/00. House: Indefinitely Postponed 02/18/00; Senate: Majority (ONTP) Accepted 02/22/00. Final Disposition: Died in Concurrence 02/22/00.
