Presented by Representative TOWNSEND of Portland; Cosponsored by Senator KILKELLY of Lincoln and Representatives: AHEARNE of Madawaska, BUMPS of China, DUNLAP of Old Town, ETNIER of Harpswell, MARTIN of Eagle Lake, PERKINS of Penobscot, PIEH of Bremen, Senator NUTTING of Androscoggin. Referred to Joint Standing Committee on State and Local Government. Public Hearing 04/09/99. Majority (OTP-AM) Accepted 05/06/99. Amended by: CA H-288. Final Disposition: Enacted, Signed 05/19/99, PUBLIC LAWS, Chapter 242.
