An Act to Fund a Minimum Level of Services for Deaf and Hard-of-Hearing Persons in all Regions of the State. Presented by Senator TREAT of Kennebec; Cosponsored by Senators: PARADIS of Aroostook, PINGREE of Knox, RAND of Cumberland, Representatives: McDONOUGH of Portland, WATSON of Farmingdale. Referred to Joint Standing Committee on Appropriations and Financial Affairs. Public Hearing 04/12/99. OTP-AM Accepted 05/07/99. Amended by: CA S-206, SA/CA S-420. Enacted 06/04/99. Vetoed by Governor 06/16/99. Final Disposition: Veto Sustained 06/18/99.
