LD 2052 / HP1429

An Act to Prohibit the Use of Juveniles in a Tobacco Enforcement Action. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 205.) Presented by Representative WATERHOUSE of Bridgton; Cosponsored by Senator LONGLEY of Waldo and Representatives: RICHARDSON of Brunswick, BROOKS of Winterport, CIANCHETTE of South Portland, SCHNEIDER of Durham, SKOGLUND of St. George, SNOWE-MELLO of Poland, Senators: DAVIS of Piscataquis, HARRIMAN of Cumberland. Referred to Joint Standing Committee on Health and Human Services. Public Hearing 04/15/99. House: Engrossed as Amended 05/05/99. Conference Committee 05/25/99. Senate: Minority (ONTP) Accepted 05/25/99, Adhere to Minority (ONTP) 05/26/99. Final Disposition: Died Between Houses 05/26/99.
