Referred to Joint Standing Committee on State and Local Government. Public Hearing 04/12/99. Majority (OTP-AM) Accepted 05/10/99. Amended by: CA H-410, HA/CA H-608. Final Disposition: Enacted, Signed 06/02/99, PUBLIC LAWS, Chapter 381.
