Presented by Representative McKEE of Wayne; Cosponsored by Senator PINGREE of Knox and Representatives: BAKER of Bangor, BRENNAN of Portland, COWGER of Hallowell, ETNIER of Harpswell, MADORE of Augusta, MURPHY of Kennebunk, O'BRIEN of Augusta, ROWE of Portland. Referred to Joint Standing Committee on State and Local Government. Public Hearing 04/12/99. Final Disposition: Majority (ONTP) Accepted 05/20/99.
