An Act to Amend the Maine Workers' Compensation Act of 1992 as it Pertains to Occupational Health. Presented by Representative COWGER of Hallowell; Cosponsored by Senator DOUGLASS of Androscoggin and Representatives: BRYANT of Dixfield, CAMERON of Rumford, DUPLESSIE of Westbrook, HATCH of Skowhegan, O'BRIEN of Augusta, SAMSON of Jay, VOLENIK of Brooklin, Senator KILKELLY of Lincoln. Referred to Joint Standing Committee on Labor. Public Hearing 01/20/00. Majority (OTP-AM) Accepted 04/08/00. Amended by: CA H-1034. House: Enactment Failed 04/11/00; Adhere to Failed Enactment 04/14/00; Senate: Enacted 04/13/00. Final Disposition: Died Between Houses 04/14/00.
