An Act to Require Legislative Approval to Lease Certain Land to the Federal Government. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 205.) Presented by Representative CARR of Lincoln; Cosponsored by Senator DAVIS of Piscataquis and Representatives: CLARK of Millinocket, JOY of Crystal, MARTIN of Eagle Lake, STANLEY of Medway, TRACY of Rome, WHEELER of Bridgewater.
