An Act to Create the Capital Riverfront Improvement District. Presented by Senator DAGGETT of Kennebec; Cosponsored by Representative MADORE of Augusta and Senator RAND of Cumberland, Representatives: MITCHELL of Vassalboro, MURPHY of Kennebunk, O'BRIEN of Augusta. Referred to Joint Standing Committee on State and Local Government. Public Hearing 04/14/99. Majority (OTP-AM) Accepted 05/20/99. Amended by: CA S-302, HA H-764, SB S-440. Final Disposition: Emergency Enacted, Signed 06/17/99, P & S LAWS, Chapter 58.
