An Act to Prohibit Law Suits by Municipalities Against Firearm or Ammunition Manufacturers. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 205.) Presented by Representative PERKINS of Penobscot; Cosponsored by Senator DAVIS of Piscataquis and Representatives: BROOKS of Winterport, DUGAY of Cherryfield, JOY of Crystal, SCHNEIDER of Durham, SHERMAN of Hodgdon, Senators: KIEFFER of Aroostook, KILKELLY of Lincoln. Referred to Joint Standing Committee on State and Local Government. Public Hearing 04/28/99. Majority (OTP-AM) Accepted 05/24/99. Amended by: CA H-442. Final Disposition: Enacted, Signed 06/07/99, PUBLIC LAWS, Chapter 430.
