LD 2221 / HP1573

An Act to Restore Majority State Funding of Public Education in Maine. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 205.) Presented by Representative BRENNAN of Portland; Cosponsored by Senator LAWRENCE of York and Representatives: BAKER of Bangor, ROWE of Portland, SAXL of Portland, SHIAH of Bowdoinham, Senators: BERUBE of Androscoggin, MURRAY of Penobscot, PINGREE of Knox, RAND of Cumberland. Referred jointly to Joint Standing Committee on Taxation and Joint Standing Committee on Education and Cultural Affairs. Public Hearing 05/19/99. Re-referred to Joint Standing Committee on Appropriations and Financial Affairs. Final Disposition: Ought Not to Pass Pursuant to Joint Rule 310 06/04/99.
