Joint Order, Directing the Joint Standing Committee on Appropriations and Financial Affairs to Report Out Legislation Authorizing a General Fund Bond Issue to Finance the Purchase of Public Lands. Presented by Representative TOWNSEND of Portland. Final Disposition: Passed in Concurrence 04/14/99. (See LD 2253 (Majority report), LD 2254 (Minority report))
