An Act to Provide for Safety in the Maine Conservation Corps. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 203.) Presented by Senator KILKELLY of Lincoln; Cosponsored by Representative CARR of Lincoln and Senators: MICHAUD of Penobscot, NUTTING of Androscoggin, TREAT of Kennebec, Representatives: McKEE of Wayne, PIEH of Bremen, TOWNSEND of Portland. Referred to Joint Standing Committee on Appropriations and Financial Affairs. Public Hearing 02/07/00. Majority (OTP-AM) Accepted 03/27/00. Amended by: CA S-568. Final Disposition: Emergency Enacted, Signed 05/05/00, P & S LAWS, Chapter 88.
