An Act to Clarify the Process for a County Bond Referendum Election. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 203.)

Referred to Joint Standing Committee on State and Local Government. Public Hearing 01/26/00. Majority (OTP-AM) Accepted 03/21/00.
