An Act to Establish Criteria for Tax Incentive Programs. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 203.) Presented by Representative GAGNON of Waterville; Cosponsored by Senator RUHLIN of Penobscot and Representatives: COLWELL of Gardiner, LEMOINE of Old Orchard Beach, STANLEY of Medway. Referred to Joint Standing Committee on Taxation. Public Hearing 02/09/00. Majority (OTP-AM) Accepted 04/07/00. Amended by: CA H-1021, HA/CA H-1055, SA/CA S-766. Final Disposition: Enacted, Signed 05/08/00, PUBLIC LAWS, Chapter 768.
