Referred to Joint Standing Committee on Taxation. Public Hearing 02/09/00. Majority (OTP-AM) Accepted 04/13/00. Amended by: CA S-637, SB/CA S-784. Enacted, 05/08/00. Vetoed by Governor 05/11/00. Final Disposition: Veto Sustained 05/11/00.
