Presented by Representative ROWE of Portland; Cosponsored by Senator LAWRENCE of York and Representatives: BAKER of Bangor, BROOKS of Winterport, FULLER of Manchester, KANE of Saco, MAILHOT of Lewiston, MAYO of Bath, POWERS of Rockport, QUINT of Portland, SAVAGE of Buxton, SAXL of Bangor, SAXL of Portland, TESSIER of Fairfield, TOWNSEND of Portland, WILLIAMS of Orono, Senators: LONGLEY of Waldo, PARADIS of Aroostook, PINGREE of Knox. Referred to Joint Standing Committee on Appropriations and Financial Affairs. Public Hearing 02/28/00. Majority (OTP-AM) Accepted 03/30/00. Amended by: CA H-941, HA/CA H-964.
